The Dealer agrees:

1. To hold all information regarding Best Water products and business activities in strict confidence, not sharing or allowing to share any information regarding to suppliers, prices, marketing, personnel or any other information shared with the Dealer by Best Water unless authorized to do so by an authorized officer of Best Water.
2. To represent all Best Water supplied product in an ethical and honest manner, making no false or misleading claims or bringing the reputation of Best Water products into disrepute.
3. To advertise Best Water supplied products at least at the recommended retail price as shown in the pricing schedule and to not discount from recommended retail prices on any advertisement unless authorized to do so by an officer of Best Water.
4. As a separate legal entity to Best Water , to hold Best Water no way responsible for the debts, liabilities and activities of the Dealer.
5. That the cost of freight to Best Water premises for any repairs necessary, after the first year, under the warranty made by Best Water, be the final responsibility of the dealer or the customer. Best Water will pay for the return shipping. To also advise the customer that the warranty for water purifiers is dependent on using decent city water, not well water or non-potable water, unless noted and accepted by Best Water.

Best Water Agrees:

1. To supply the said appliances and products to the Dealer at the agreed price after receiving the purchase order and payment from the Dealer.

2. That the cost of servicing the manufacturer's warranty, Best Water supplied products, remain with Best Water. (Return shipping costs to BW may be the responsibility of the Dealer.
3. To keep all information regarding the Dealer and their business activities in the strictest confidence, neither sharing nor allowing to be shared any information regarding pricing, supply, marketing or personnel or any other information relating to the Dealer's business activities unless authorized to do so by the Dealer.
4. That the Dealer as an independent distributor and a separate legal entity is in no way responsible for the debts, liabilities and activities of Best Water.
5. That the dealer may represent the Best Water range of products, under their own brand and trademark with no reference to the Best Water name, logo, brand or trademark
6. That the dealer may establish agents and associates for the purpose of soliciting purchase orders for the Best Water range of products in any location in Canada.
7. To supply said products to the Dealer while they continue to trade in said products, or hold Canadian distributorship rights for said products and may not withhold supply of said products for any reason, other than if the Dealer has been determined to have breached this agreement by a relevant court of law or body of arbitration legally empowered under Canadian law to make such determination.

Best Water and the Dealer Agree

That this agreement is for a period of Two (2) years and thereafter will automatically renew for each two (2) year period provided the agreement is upheld. Either party shall be entitled to termination of this agreement upon the default of the other. Thirty (30) days written notice of intended termination of agreement to be provided if no default has occurred.

This Agreement and the pricing schedule collectively constitute the entire agreement between the parties hereto. No representations, guarantees or warranties, written or oral have been made or given by the Dealer of Best Water or any of their employees or agents other than those set out in the contract documents.
